	How do none accredited professionals refer to another accredited professional?	A written letter summarising the patient's ocular condition and challenges, as now. EHEW referral paperwork can be used.

	Who is responsible for making the appointment post referral- the practice or the patient	We recommend that the practice reach out to make the appointment with the patient once a referral has been received.
	As eligibility is for a patient either with a GP in Wales or resident in Wales, does this exclude cross border patients where they may live and have a GP in England, but ordinarily choose to have their eyes tested in Wales?	Yes this excludes these patients. Only those who have a GP in Wales or live in Wales are able to access the service.
	can you perform more than one full assessment a year if circumstances change	Yes, so long as the criteria in section 6.1 of the clinical manual are met.
	What if you are unsure if dry or past wet AMD is the cause?	If you are unsure of the cause of vision impairment then the patient needs to be referred to secondary care for Certification of Vision Impairment

	Do you envisage most patients having a follow-up exams, or only if they report a change etc?	We envisage a mix of Assessments and Follow-ups from every practitioner. The time to do a full Assessment is clearly articulated in the WGOS manual.
	I know you will not get paid, but can you still do a follow up over the phone and only see them if they are having problems ? a lot of patients do find it difficult	A curtesy call to patients to see how they are getting on with the LVAs and with any referrals made would be considered to be good practice. No fee would be claimable and under WGOS3 this would not be classed as a follow up (as this needs to be performed face to face and attracts a fee)
	Good evening, could you please confirm if a patient who had LV assessment in a practice over 12 months ago with no change of circumstances, be able to have LV assessment or would it be a follow up LV ?	This would be a follow up, unless one of the following criteria is met; (Section 6.1 WGOS manual) The patient is entitled to a WGOS 3 Low Vision Assessment: • At the point of entering the service; • When the patient is seen by a Practice for the first time and has not had a Low Vision assessment within the last 12 months; • When following a WGOS 1 Eye Examination or Private Sight Test, the patient's



		vision has changed significantly; and/or • Significant changes in a patient's personal circumstances.
	How do we stand legally if we are performing a LV follow up and miss a pathology as ophthalmoscopy is not performed as a follow up?	A WGOS 3 Low Vision follow up is a service based on functional needs. It is not a clinical assessment. Our view would be that if you suspected a patient required a clinical assessment (eg, their need is not as expected) then your duty of care to that patient would extend to you arranging a clinical assessment, as part of WGOS 1 / 2 as relevant. Please see advice from your legal representative body for legal advice.
	Are we supposed to perform FRAT and depression screening as a follow up?	This would be down to your clinical judgement as during a follow up you would perform investigations relevant to the presenting need of the patient.
